NewRX

Route new prescriptions directly to the patient's pharmacy of choice.

Rx Change

Pulls all information for Rx Change requests available by patient, clinic, clinician, or client.

Rx Refills

Lists prescription renewal requests electronically by patient, clinic, clinician, or client.

Interactions

Returns results of drug-drug interactions and drug-allergy interactions for the patient.

ePA

Initializes the prior authorization request to be completed online or offline.

EPCS

Ensures all EPCS certifications and third-party audit documentation as required by the DEA is met before a prescription can be transmitted.

RTPB

Allows providers to select patient-specific medications covered by insurance.

IDP

Initialize clinicians to begin the identity proofing process required to write prescriptions.
